INSTRUCTIONS

Information Required on a Uniform Exemption Certificate

A properly completed Exemption Certificate must include:

- Name, address, and nature of the business
- List of items being purchased for which an exemption is being claimed (i.e. shipping supplies)
- Vendor Permit number, Seller's Permit number, Tax Exemption Certificate number, Authority, if applicable (due to the nature of their operation, some manufacturers, wholesalers and contractors do not require a number) or State
- Signature of the purchaser or an approved official of the business
- Date the certificate is being issued
